And almost 5 Million young voters who will turn 18 years old or older by election day will vote for the first time in 2020 elections.

You have to be on the voter list to be able to cast your ballot. Make sure you check your name during the display period and make use of your rights to vote in the election! If you are abroad, you still can check your name online. Stay tuned for details!

## Check Now

From 25 July to 7 August 2020 at your ward and village tract sub-commission office!

# You must make sure your name is included in the voter list in order to vote.



## Step 1

**Check the voter list** during the display period. Remember to check the dates with the ward and village tract sub-commission.



## Step 2

**If your name is on the voter list in a correct form**, you are ready to vote for the 2020 elections. **URGENT: If you see that something on the Voter List needs to be corrected, added or deleted proceed to step 3!**



## Step 3

Remember you need **to only need to submit the correct form if:**

- your name is not included on the voter list (Form 3)
- your information needs to be corrected (Form 4-C)
- a voter is listed that should not be included (Form 4)

**Submit the necessary form** to the ward village tract sub-commission within 14 days from the display period. If necessary, attach a copy of your ID card, certificates for residence or other evidence. There is no fee.

- you have been living away from your permanent residence for more than 90 days. (Form 3-A). Submit 30 days before the election date.



## Step 4

**Check the status of your request** with the ward-village tract sub-commission not later than 7 days after submission.



## Step 5

**Appeal the decision** to the township sub-commission if you are not satisfied with the decision. The appeal form **MUST be submitted within 3 days to the township sub-commission**. The township sub-commission decides immediately.



*My name is San San. My father is eligible to vote but his name was missing in the Voter List. What can I do?*

Q1

A1

If an eligible voter is not in the voter list, then **Form 3** should be submitted to the ward village tract sub-commission in accordance with instructions with 14 days from the display. Your father may be required to present evidence of eligibility and residence.

Q2

*My name is U Chit. My name is included in the voter list but a few details are wrong. What can I do?*



A2

If an eligible voter's information is shown incorrectly, **Form 4-C** should be submitted to the ward village tract sub-commission in accordance with instructions and within 14 days from the display.

Q3

*My name is Mya Mya. I see a name on the voter list that should not be there. What can I do?*



A3

If you find a record of a person who should not be on the voter list, **Form 4** should be completed at the ward village tract sub-commission in accordance with instructions within 14 days from the display. You have to state your reason for objection and provide. But you cannot object one outside of your voter list.

Q4

*My name is May Oo and I turned 18 in June 2020, can I vote in the upcoming election?*



A4

If you are eligible to vote, you have to make sure your name is included in the voter list. Check with your ward village tract sub commission office or during the voter list display. If you name is NOT on the voter list, make sure to add the name by submitting **Form 3**. The Form can be submitted to the ward and village tract sub-commission within 14 days from the display.

Q5

*My name is Pan Ei and I have been living away from my permanent residence and cannot return there for elections!*



A5

If you have been living in your current location for more than 90 days you can request **Form 3-A** from the ward or village tract sub-commission. You may also need to provide:

- A letter of recommendation from your Supervisor (Civil Service) or company owner or:
- Provide your own self-declaration endorsed by the Ward or Village-tract Sub-commission, saying that you have lived in this location for more than 90 days.

You must submit Form (3-A) not later than 30 days prior to the Election.
